Survey of English Usage Annual Report 1984-85

1. General

This year witnessed the publication by Longman of A Comprehensive Grammar of the English Language by four scholars closely associated with the Survey: Professor Sir Randolph Quirk (founder and first Director of the Survey), Professor Sidney Greenbaum (its present Director) Professor Geoffrey Leech, and Professor Jan Svartvik (formerly Assistant Director). Professor David Crystal, who began his career by working at the Survey, compiled the index of 113 pages. The new grammar is the climax of twenty years of collaborative work by the four authors. Building on A Grammar of Contemporary English, acknowledged since its publication in 1972 as the standard reference work in the field, it is an even more comprehensive synthesis of current grammatical description of the English language.

Congratulations are due to Professor Quirk on his knighthood, announced in January 1985. Sir Randolph Quirk retired as Vice-Chancellor of the University of London in August 1985 after a distinguished four years of office. He will be returning to the Survey to continue his research and writing.

Longman has renewed for another seven years (beginning 1985) its generous donation of the Longman Research Fellowship, which is attached to the Survey. The fellowship was advertised early in 1985, and a large number of excellent applications were received. The Longman Fellow for 1985-6 will be Dr Anna-Brita Stenström, one of the

researchers at the Survey of Spoken English, University of Lund. Dr Stenström has written extensively on spoken discourse.

A new one-year M.A. course was successfully inaugurated this year. The students were trained in the grammatical analysis used in the Survey and also in the Survey system for transcribing prosodic and paralinguistic information in spoken texts.

2. Visitors

The Longman Fellow for 1984-5 was Dr Jan Firbas of Brno University (Czechoslovakia), the leading authority on Functional Sentence Perspective. During his stay at the Survey, Dr Firbas wrote several papers and began work on a book that will be a synthesis of his researches into functional sentence perspective. He conducted a weekly seminar for members of the Survey, attended also by staff and graduates from other London colleges, and gave a lecture to undergraduates in the Department of English at University College.

3. The Year's Work

Sylvia Chalker, Oonagh Sayce, and Tom Lavelle have continued to work on first-stage grammatical analysis; some analysis was also undertaken by Bas Aarts and Nicholas Jones, students on the M.A. course. Between them they have analysed fifteen texts, bringing the total of texts analysed and filed so far to 152 (66 written and 86 spoken). Boase transcribed four spoken texts and provided them with prosodic paralinguistic Valerie and marking. Adams checked transcriptions and with Tom Lavelle proofread the typed texts. Grace Stewart and Vanessa Kuehner collected the prosodic and paralinguistic features in the spoken texts. René Quinault has continued to maintain the files of the Survey offprint collection and to select and prepare tapes for transcription. Several other members of the Survey team have assisted in the selection and recording of new texts.

Professor Greenbaum gave a paper and chaired a session at the conference on grammatology at the Freie Universität Berlin, chaired a session at the Sixth International Conference of English Language Research on Computerized Corpora at Lund, and lectured at the University of Lancaster. He also gave the annual Saussure lecture sponsored by the Polytechnic of Central London.

Dr Robert Ilson has become a member of the editorial board of the new OED. He gave papers at conferences at the universities of Leeds and Lodz, and lectured at the University of London Institute of Education and the universities of Exeter and Birmingham. He was interviewed on lexicography by the BBC World Service. Apart from the publications listed in the following section he wrote regularly for the EFL Gazette and the Times Educational Supplement.

Dr Firbas delivered lectures at the universities of Essex, Lancaster, Leeds, and Reading. R.A. Close read a paper at the IATEFL

conference. Janet Whitcut lectured in Delhi on a tour sponsored by the British Council. Professor Akimoto, who spent a year at the Survey, gave a paper at the LACUS conference.

4. Publications

We occasionally fail to record publications. Scholars who have used Survey material are urged to send offprints to the Survey. If publications from previous years have not been listed, please let us know. We keep lists of Survey publications, and we bring them up to date periodically.

We do not list reviews (unless they are review articles) or articles in newspapers or popular magazines.
