# Social Determinants of Health

### **Where will the summer school be held?**

The summer school will be held at UCL which is located in central London, close to Regent's Park, the British Museum, the British Library and West End shops and theatres.

### **What is included in the fee?**

- All course materials and a supplementary reading list
- Library and Internet access
- Lectures and seminars by senior staff – approximately 30 contact hours
- Guest speakers
- Lunch, morning & afternoon tea each day and social events
- Access to the University of London gym and sporting facilities

### **Are the courses accredited?**

- All participants will be issued with a Certificate of Attendance.
- Faculty of Public Health CPD credits can be claimed
- One ECTS credit may be claimed

### **Is accommodation provided?**

The course is non-residential. You will need to arrange your own accommodation in London if necessary. We recommend College Hall, which is only 5 minutes away from the summer school venue. The Hall is managed by the University of London. An en-suite single room including breakfast costs £60/night. Booking needs to be made directly by email at: [info.college@london.ac.uk](mailto:info.college@london.ac.uk) – do specify that you wish to stay at College Hall. College Hall is opposite the University of London Union sporting and recreational facilities. We can provide you with a list of other accommodation (varying rates) within walking distance of the summer school upon request.

### **Who is the summer school designed for?**

The summer school is designed for two types of participant: those who already work in the field of public health and who want to refresh their knowledge of population health, and those who are considering a career in public health or related research such as social epidemiology and health policy (national and global). Our course is multi-disciplinary.

### **What topics will be covered over the five day course?**

Class, Work, Gender, Ethnicity, Social-biological translation, Life course epidemiology, Mental health, Oral health, Disability, Inequality and human rights, Russian mortality crisis, Tackling Health Inequalities, Public health ethics, Politics of health and equity, Globalization and health.

Michael Marmot will open the summer school with a presentation on the social determinants of health and close the week with a lecture and discussion on national and international policy development. There will be two evening events: Carolyn Stephens of the Universidad Nacional de Tucumán, Argentina on 'Ecology and Global Health' and Naomi Eisenstadt a Senior Research Fellow at the University of Oxford on 'Policy making on social determinants of child outcomes: a view from inside government.'

### **Summer school hours**

The full programme will run Monday – Friday between the hours of 9am – 5pm approximately with additional events on Monday and Thursday evenings.
