

UCL Assessment Operating Model 2022/23

Introduction

This Assessment Operating Model is part of the **UCL Teaching and Assessment Operating Model for 2022-23**. It is a staff-facing document which summarises the seven different assessment types which can be used for centrally-managed and departmentally-managed assessments.

The Operating Model is accompanied by detailed regulations for students for each different type of assessment. These aim to improve clarity by drawing together everything that students need to know about a particular method of assessment in a single location

Types of Assessment

For regulatory purposes, the Operating Model groups assessments into defined categories with discrete regulations. There is no intention to curb the breadth and innovation in assessment design that UCL values highly. It is recognised that departments may have their own terminology and definitions, but this shared terminology aims to promote operational clarity and consistency across UCL. The majority of assessments should fall into these groups, but there may be occasions where an assessment is difficult to categorise. Notes

In-person Controlled Condition Exams	<p>In 2022/23, centrally-managed In-person Controlled Condition Exams will be held at the ExCel Centre as a paper based exam. There will also be separate, dedicated Exam Adjustments facilities with PCs for eligible SORA students. Departmentally-managed In-person Controlled Condition Exams will be held in departmental accommodation.</p> <p>Departments should do everything possible to avoid sending the students to the ExCel for short exams (i.e. 60 and 90 minutes) and the experience for all students in the hall will be enhanced if examinations are scheduled in whole hours (i.e. two or three hours).</p>
Take-Home Papers	<p>The use of 24-hour Take-Home Papers is strongly discouraged and should only be used in exceptional circumstances. There is evidence that 24 hours is an unsuitable duration in terms of student wellbeing and academic integrity. For this reason, 24-hour Take-Home Papers will not be centrally timetabled. The UCL Central Assessment Team is unable to guarantee that a student might not have a Controlled Condition Exam overlapping a departmental 24-hour Take-Home Paper period.</p> <p>There is no additional Upload Window for Take-Home Papers as extra time is already built in. The Student Regulations instruct students to leave themselves at least 20 minutes for uploading and submitting.</p>
Online Exams	<p>Online exam durations should be the same as in-person exam durations for an equivalent assessment. Online exams have an additional 20-minute Upload Window to give students extra time for the additional task of uploading and submitting their work. However, some exams may have particularly complex upload requirements and will therefore require additional collation time (e.g. multiple files, large-format files, taking photographs, converting handwritten notes into PDF) and 20 minutes may not be sufficient. In these cases, Departments are asked to extend the duration of the individual exam to allow students more time for uploading, and clearly state on the front of the Examination Paper what the writing time, collation time and upload window is. Departments can extend the individual exam duration to a <u>maximum of four hours</u>.</p>
Extenuating Circumstances	<p>The 'Recommended Self-Cert EC Mitigation' is designed to promote consistency across UCL and manage student expectations about the likely outcome of an EC claim. The other mitigations in the standard Extenuating Circumstances Procedures are also available to EC Panels, although we would normally expect students to provide evidence for these.</p>
Derogations	<p>BA English operate a finals system with 6-hour exams. These will continue to be allowed as a derogation. They will fall under the regulations for 'Controlled Condition Exams'. However, they will be departmentally timetabled and managed.</p> <p>Assessments in the MAPS Faculty may be set up in Crowdmark.</p>
