

## UCL Accommodation 12 Days of Christmas 2021 Competition Terms and Conditions

This competition is promoted and operated by UCL Accommodation. Details of how to enter form part of these terms and condition ('Terms'). It is a condition of entry that all rules are accepted as final and that the participant agrees to abide by these rules.

### Eligibility

1. The prize draw is open to all current UCL Accommodation 2021/2022 residents who are present in the UK at the time of the competition.
2. UCL or associated third party contractor staff members are not eligible to enter the prize draw.
3. Residents who have left UCL Accommodation are not eligible to enter the prize draw.
4. Participation is non-transferable and you shall only be entitled to take part once each day over the 12 day period.
5. Participants must be 18 years of age and older.
6. The prize draw closes at 11.59pm each day over the 12 day period. Any participant submitting an entry after this deadline shall not be able to take part in that particular day of this competition
7. No responsibility will be accepted for incomplete or lost entries or entries not received.
8. Winner will be drawn randomly by UCL Accommodation each day if they have chosen the correct number and the winner will be notified directly via direct messaging on Facebook or Instagram. The winner will also be announced on UCL Accommodation Instagram and Facebook.
9. Only one entry per person. Multiple entries will be disqualified.

### The Prize

1. There is a total of 12 prizes.
2. If you are not fortunate enough to win, you shall not be entitled to any prize and we shall have no liability to you in this regard.
3. Prizes are non-transferable, non-exchangeable and no cash alternative is offered.
4. Prizes may not be transferred or sold.
5. If we are unable to contact a winner, or the winner does not claim the prize within 30 days of being notified then they will forfeit the prize.
6. To claim the prize the winners must follow the instructions in the email notifying them that they are the winner.

### Privacy

1. Any information and data provided or collected in accordance with the competition will be dealt with in accordance with the provisions of the EU General Data Protection Regulation ('GDPR').
2. Personal data supplied during the course of the competition will be used to arrange delivery of the prize.

## Changes to these Terms

1. We reserve the right to change or amend these Terms.
2. If you do not accept the notified changes, you will not be permitted to enter the competition. If you have already entered the competition, we reserve the right to withdraw your entry and shall not be liable in this regard.

## General

1. We reserve the right, at our sole discretion, to refuse participation in this competition.
2. We reserve the right to refuse to award a prize to anyone in breach of these Terms.
3. The winner may be required to participate in publicity which may include the publication of names and photographs in any media.
4. Events may occur that render the awarding of the prize impossible to reasons beyond our control. Accordingly, we may, at our sole discretion, vary or amend the competition and you agree that no liability shall attach to us as a result thereof. We reserve the right to cease the competition, withdraw or substitute any prize at any time prior to the redemption of the prize.

We shall under no circumstances whatsoever be liable to you whether in contract, tort (including negligence), breach of statutory duty or otherwise for any loss (including indirect and consequential losses), damage, personal injury or death arising out of, under or in connection with the competition or these Terms.
6. Our decision in all matters is final and binding. No correspondence will be entered into.
7. These Terms constitute the entire agreement between us and you.
8. We may at any time assign, transfer, subcontract or deal in any other manner with all or any of our rights or obligations.
9. If any part of these Terms is or become invalid, illegal or unenforceable, they shall be deemed modified to the minimum extent necessary to make them valid, legal and enforceable. If such modification is not possible, the relevant provision or part-provision shall be deemed deleted. Such deletion or part deletion shall not affect the validity and enforceability of these Terms.
