Welcome to the third edition of the BENCHISTA Newsletter. We are very grateful for your continued support and participation in the study.

In this issue, we provide information about the project's progress, activities completed since our last update in July 2022, communication and dissemination opportunities.

Highlights

The BENCHISTA Project has current participation from 69 Population-Based Cancer Registries (PBCRs) from 25 European countries, Australia, Brazil, Japan, and Canada.

To the third week of December, the data controller (INT) has received 41 databases.

The Data Transfer Agreement (DTA) developed to meet specific legislations to adhere to GDPR and relevant laws has been finalised and signed.

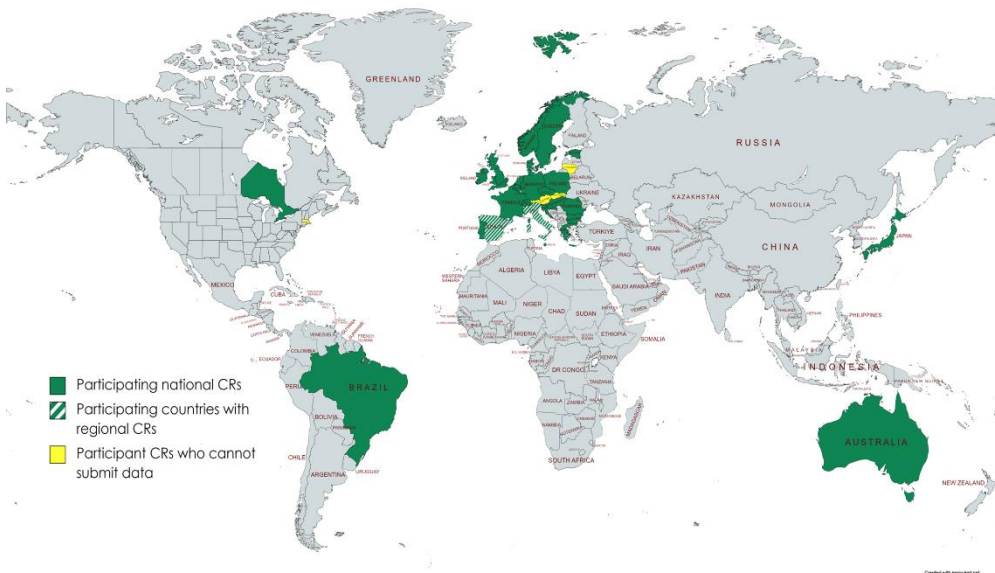

The Data Transfer Agreement (DTA) was fully executed on 14th of November 2022. Thanks to the team and legal officer at INT, who is currently distributing the complete signed document to the PBCRs for their availability.

A new 'accession document' has been created. This is addressed to new parties who would like to join the BENCHISTA Project. Noting that *no* changes to the initial format are allowed. Further information can be provided by contacting the BENCHISTA team via [email](#).

Amendment No.2 (updated protocol and appendix v4.4, 22 Sep 2022) was approved by the UCL Ethics Committee on 03rd of October 2022.

We highlight the importance of the dataset transfers within the previously agreed timeline as it will allow us to start the data analysis accordingly.

Once we have all information on the cases numbers submitted by PBCRs, we will be able to start generating the reimbursement per case.

During our last Project Working Group meeting – held on 14th December 2022, we shared the PBCRs/Countries pending to submit their answers to the registry questionnaire and the fictitious cases staging exercise. Please remember that these are open and expected to be completed by all.

Quality Assurance Tool (Containing 12 fictitious cases)

We aim to assess how standardized is the collection of Toronto Staging across the participating PBCRs.

Up to July and from the answers received, the average correct score was 89% and the median score 92%.

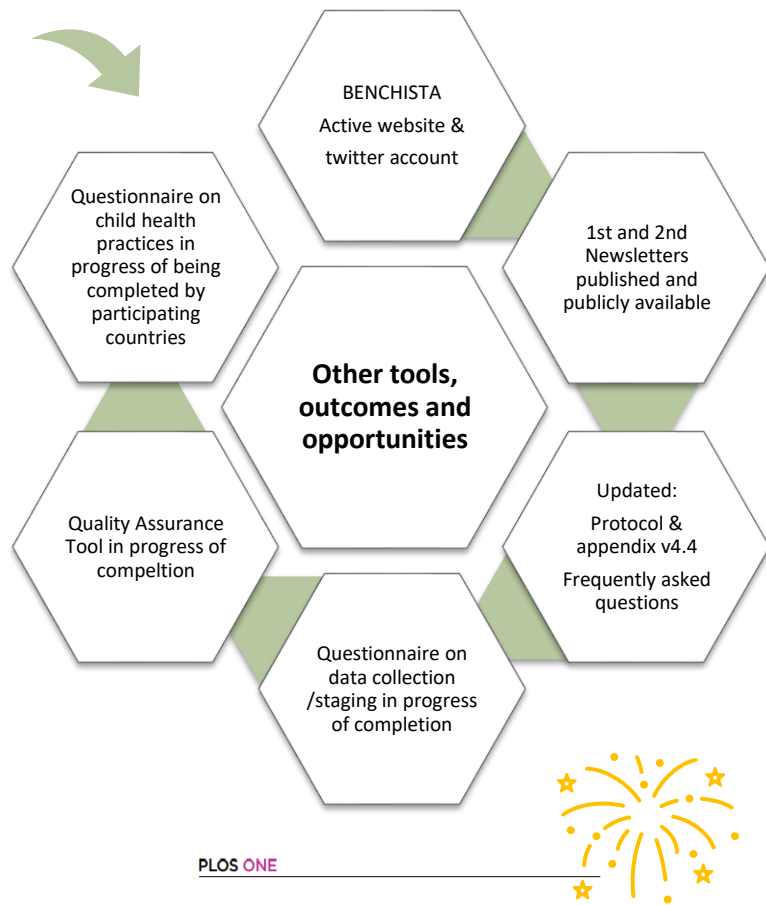

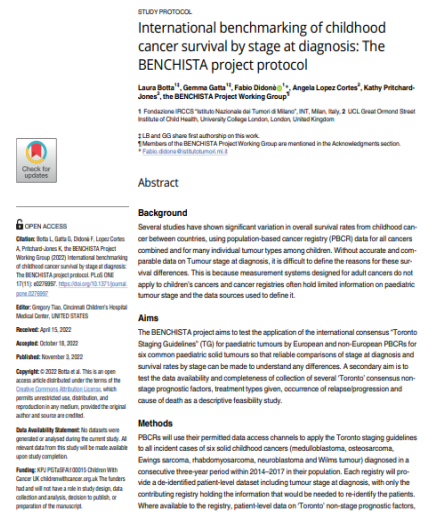
