### Attending the Data Access Public Review Panel meeting – what do applicants need to do?









## What guidance is available for applicants?

#### Writing a Lay Summary

This guide aims to provide you with the information you need to produce a lay summary that has the best chance of being understood and approved by the Public Review Panel on the UK LLC Data Access Committee.

#### Answer these key <u>questions:-</u> (200 word limit)

What are you aiming to achieve?

What is your plan to achieve this and how will having access to the data be important?

How will this work benefit the public? Be specific if you can e.g., benefits to underserved communities, benefits to the economy, benefit to people with a certain health condition etc. Tell us how your work will be taken forward, even if that won't be by your team.

#### Things to avoid:

Don't use scientific jargon.

Don't use acronyms, always write them out in full. Exceptions are where the acronym is more widely used by the public e.g. UK not United Kingdom, GP not General Practitioner.

Don't give too much detail on the background to the research question – focus on answering the key questions.

#### Tips and Tools:

Always remember your audience - this part of the application is for members of the public. If they don't understand what you've written, you'll be asked to amend your lay summary.

Write as you speak, not as you write. Use Plain English: Free guides (plainenglish.co.uk) Read the text aloud. If you run out of breath before you've finished a

sentence, it's too long. Keep sentences short, average 15-20 words.

## Writing a lay summary

Use these questions to frame your summary:

What are the aims of your project and what is the plan to achieve this?

How will the data help you?

What are the benefits to the public?







## Writing a lay summary – real life examples

### Before:

Bringing all this information together in one place and linking it to information from NHS around things like when and where people have been ill, what treatments they have received will be an incredible amount of information to answer many research questions to better understand things like long Covid-19 and to help understand how to improve health services and treatments and therefore outcomes for people with Covid-19





### After:

Bringing this data together in one place and linking it to data from the NHS will help to answer many important research questions, including better understanding long COVID.

It will provide information to improve health services and treatments for people with COVID-19.

## Writing a lay summary – real life examples

#### **Before:**

pre-existing health conditions

inform decisions about who should be <u>prioritised</u> for future COVID-19 booster vaccinations

Aspects of people's lives

Public Involvement – looking for specifics, not that someone somewhere runs Patient and Public Involvement If you're lucky enough to have someone who delivers this, ask them for this content.





### After:

- had other health problems
- Inform decisions about who should be <u>put first on the list</u> for future COVID-19 booster vaccinations
- Information on people's lives
