Who runs ELSA?

The English Longitudinal Study of Ageing (ELSA) is a collaboration led by University College London involving the National Centre for Social Research (NatCen), The Institute for Fiscal Studies, The University of Manchester and The University of East Anglia. The research is funded by a number of UK government departments coordinated by the National Institute for Health Research, and the National Institute on Aging in the United States. Funding has also been provided by the Economic and Social Research Council (ESRC).

How are the ELSA results used?

ELSA helps to build a picture of ageing in England and the data is used for statistical and research purposes only. Government, charities and academics use ELSA data when thinking about policies and initiatives for people aged 50 and over, including things like work, pensions and healthcare, which could affect you and your family.

When will the interview be?

We realise that you may be busy, so we'll organise the interview at a time that suits you. This could be in the evening or at the weekend if you prefer. In the coming weeks your interviewer will contact you to discuss taking part and arrange an appointment to conduct the interview in your home. If you prefer, a video call can be arranged instead.

What will the interview be about?

We would like to ask you some general questions about your health and living standards, as well as asking you to do some simple problem-solving exercises. Some of you will also be invited to take part in a health visit which your interviewer will tell you more about.

Can a friend or family member be present during the interview?

Yes, if you want a friend or family member there during the interview then this is certainly possible.

How do you safeguard my privacy?

We will treat your information in the strictest confidence under UK GDPR data protection legislation. Your answers are put with those collected from people across England and the survey findings are used for research that benefits society. You will not be identifiable from the published results.
