

User Guide

When a resident enters the care home for the first time they should have an Oral Health Assessment (1a) to begin to understand their specific needs, including any potential risks to their oral health (1b). Once the assessment is complete this information can be used to create a formal plan (2a). This will keep track of the residents preferences of products as well as routines that work for them. This is distilled into a more informal summary which can be kept in the residents room for easy access (2b).

A guide on how to deliver oral care, especially to people who might resist it, is included as a poster that can be displayed in staff rooms and offices (3a). This is combined with a set of Tips and Tricks Cards that collect useful strategies from care homes across the country (3b).

Finally the residents oral health is monitored on a weekly basis with the Weekly Care Record, this is also a good place to record any tips and tricks that have improved care for this resident. This information can then be easily accessed by care home staff. When 12 months pass or if any significant change is noticed return to 1a and deliver another assessment.
