58 **ACADEMIC BOARD MINUTES**

58.1 The minutes of the Special meeting of 9 June 2023 [AB Minutes 44-45, 2022-23] and the meeting of 14 June 2023 [AB Minutes 46-57] were confirmed.

60 **PROVOST'S REPORT** (Paper 7-01)

60.1 Noted.

61 SSEES AND THE FACULTY OF ARTS & HUMANITIES (Paper 7-02)

- 61.1 The Dean of the Faculty of Arts and Humanities and the Director of the School of Slavonic and East European Studies (SSEES) introduced the proposal that SSEES be integrated into the Faculty of Arts and Humanities with effect from 1 September 2023.
- SSEES had joined UCL in 1999, initially as a discrete unit sitting alongside the 61.2 Faculties of Arts & Humanities and Social & Historical Sciences (SHS). As UCL had grown in size and complexity since that time, the structures enabling the continuation of that arrangement had come under strain. In recent years SSEES had been informally represented at school (SLASH)² level. It had also developed a functional relationship with the Joint Faculty structure (Arts & Humanities and SHS), a relationship which had been further strengthened during the covid period, notably by way of access to the Joint Faculty education team. The Faculty of Arts & Humanities had also come to play a facilitating role in many processes within SSEES, such as senior promotions. UCL's school structure (including SLASH) had now been abolished, and in view of the growth of the two faculties the Joint Faculty arrangements were also being dissolved. This risked leaving SSEES in an increasingly isolated position, notably in respect of reporting lines and the provision of education functions.
- 61.3 The proposal to assign SSEES formally to the Faculty of Arts & Humanities had been raised some years ago, but first discussed with SSEES staff generally in June 2022. There had been a year of consultation and discussion, with opportunities to engage with the Dean since that time. A Memorandum of Understanding between SSEES and the Faculty had been agreed in March-April 2023.
- 61.4 A letter from 15 SSEES members of AB had been circulated in advance of the meeting, setting out their opposition to the proposals and requesting an extension of the consultation process. In discussing the consultation process members raised the following issues:
 - a. The proposals had been presented to members of SSEES in June 2022 as a *fait accompli*, which discouraged engagement. In particular, there had been no discussion of alternative options; members cited the preponderance of SSEES students and staff working in social sciences

- rather than arts and humanities disciplines. The Academic Impact Statement currently before the Board was identified as the first written rationale for the proposal seen by SSEES staff. Members contrasted the process with that recently initiated in respect of a proposed structural change in the Faculty of Medical Sciences. The Provost noted that the SSEES proposal was fundamentally different in character to that in the Faculty of Medical Sciences as it related to the formal recognition of a relationship that had been functioning for some time, but acknowledged the case made by staff that the process was not as extensive or transparent as it might have been.
- b. A number of factors had contributed to the relatively low level of engagement with the process, notably the pressure on SSEES staff in the early months of Russia's full-scale invasion of Ukraine, and a reticence to engage in a process about a proposal to which individuals objected. It was noted however that there was no reason to expect that this would change if the consultation period were to be extended as requested.
- The vision for the proposal was to preserve SSEES's academic standing whilst giving it greater financial and strategic stability within a formal faculty structure, for example through access to faculty RCIF funding and scholarships. Although the disciplinary breadth of SSEES overlapped with several faculties, the Faculty of Arts & Humanities was already home to several interdisciplinary units and there was no reason for the proposed structure to hamper links with SHS. The proposal would also provide SSEES staff with an opportunity to take on faculty leadership roles. It was suggested however that the rationales presented were fundamentally administrative in nature, rather than academic- or research-driven, and had not taken a strategic approach to considering the options available, nor fully considered the risks and complexities that could arise as a result. Members expressed differing views of the extent to which UCL's internal structures would impact external perceptions of SSEES.
- 61.6 The letter from members alluded to other potential structures, including the incorporation of SSEES into an area studies platform within the Institute of Education. It was suggested however that this was founded on a misunderstanding of the purpose of the Policy Commission for Area Studies, which was chaired by the Director of the IoE, and which was tasked with reviewing UCL's provision of high-impact policy advice in Area Studies. The Commission was not considering structural arrangements.
- 61.7 In respect of Academic Board's responsibility to advise Council, members were invited to vote on the proposal that SSEES become an academic unit of the Faculty of Arts & Humanities with effect from 1 September 2023, or (if not supported) subsequently to vote on the alternative proposals put forward by 15 members.

61.8 On the question of whether members supported the proposal, 156 members of Academic Board voted as follows:

Yes	60	38%
No	52	33%
Abstain	44	28%

61.9 Academic Board's views would be passed on to Council. In summing up, the Provost noted that the conversation had drawn attention to the broader question of area studies, and proposed that Academic Board receive a presentation on that in due course.
