7. Student Numbers Planning (1-05)

- 7.1. The paper set out projected student numbers to 2027/28, aggregated at the institutional level, on the basis of individual discussions with faculties. The intake targets had been approved at UMC. There were grounds to treat the modelling of student numbers with caution, as experience showed that the forecast trajectory tended to be an underestimate. Work was ongoing to develop more accurate methods of forecasting student numbers and to understand the behaviour impacting conversion rates.
- 7.2. Members cited the need to adopt a more 'joined up' approach between different functions. The Admissions Transformer was ongoing but was principally concerned with capacity, although a second stage of that process could seek to address how recruitment, admissions and faculty policy could be drawn together.
