42. Tuition Fees for 2023-24 (6-04)

- 42.1. Mr Dean Stokes, Director of Planning, introduced the paper which presented proposals for unregulated tuition fees (undergraduate international and all postgraduate fees) in the academic year 2023-24.
- 42.2. A number of points were raised in discussion, including:
 - a. In response to a question, the Director of Planning confirmed that once tuition fees had been set, it would not be possible to make changes to these due to Competition and Markets Authority (CMA) regulations and fee guarantees being applicable for the duration of a student's course.
 - b. In response to a question as to whether the market would bear tuition fee increases, the Director of Planning advised that this was accounted for within the banding structure and courses were banded accordingly to mitigate this risk. Application numbers remained steady despite increasing fees.

- c. In response to a question, the Director of Planning advised that the possibility of international competitor analysis was being explored, but this kind of analysis was challenging to do.
- d. The Vice-Provost (Faculties) reported that application closure dates were being looked at as part of the admissions review. For undergraduate courses, these were bound by UCAS dates. For postgraduate courses, there was more flexibility, and the aim was to keep these dates early where possible to allow sufficient time for the team to process applications.
- 42.3. FPC recommended to the University Management Committee (UMC) the headline increase of 8% for UCL's unregulated tuition fee bands in 2023/24.
