¹ Following the FPPC meeting, Alison Sidebottom, Degree Apprenticeship Manager, advised that UCL was not currently approving new apprenticeship qualifications. There was a review of apprenticeships was underway and a paper on the future of apprenticeships due to go to UMC for approval. The ACCP team were advised to move forward with seeking approval as it would be possible to add an apprenticeship qualification at a later stage. The process could be initiated by September 2023 for a new programme to launch in September 2024.
