- 76. Operation of FPPC
- 76.1. Under 'Any Other Business', the Chair noted that this was the last FPPC meeting of the current academic session and members' views were sought

on the operation of FPPC. During discussion, the following points were made:

- a. Overall, members considered that the committee was working well. It
 was suggested that a representative for UCL East be added to the FPPC
 constitution and membership.
- b. It was felt that the governance around which items should be considered by University Management Committee (UMC) and/or FPPC could be made clearer. It was noted that in terms of delegation limits, proposals above £10m were considered by Finance Committee and those which fell below that limit would be considered by FPPC. UMC was responsible for the strategic conversation around any proposals although FPPC could help shape the principles.
- c. In terms of Stage Zero proposals, it was queried whether FPPC was duplicating the process for considering proposals that occurred at UCL's Programme and Module Approval Panel (PMAP).
- d. It was noted that a number of late papers had been submitted to FPPC over the year, for various reasons, and that firmer requirements could be set in that area by the Secretariat.
