ONE-TIME PROJECT SETUP (TOTAL : £1000)

An initial cost that covers any contract or data sharing agreement administration, project setup, initial data import and auditing from external collaborators or partners, data protection impact assessments.

DATA STORAGE ONLY (£300/TB)

For individuals who wish to use the JDRL as a location for long-term storage of data which requires a specific level of security.* For researchers, some funders require the storage of data for 10+ years. We provide a secure facility to do so. In addition, if you are required to make your data available to the wider community, please get in touch as we can suggest some ways to do so, whilst preserving the security of sensitive data.

* This service does not provide a user account for data analysis.

USER SET UP (£200 PER USER)

These costs cover the creation of a user profile in the data lab, installation of any non-standard software*, provision of one access card, and a mandatory induction session. Access to the lab is only provided to those individuals who have gained appropriate vetting clearance. Where a user does not already have clearance, this can be obtained and the prices for this service are given below.

*Any non-standard software will require the approval of the lab technical committee and software and license costs will need to be covered by the user.

DATA PREPARATION, ANONYMISATION & ANALYSIS COSTS (£100 PER HOUR OR £600 PER DAY BASED ON SCOPE OF WORK)

This may be useful for individuals who require particular subsets of currently available datasets in granular form and may allow the data to be exported for use outside the lab. If you require assistance with reshaping the data or aggregating it (such as to higher level geographies, annualised counts, etc.) please speak to the lab manager or director and we will see if we can help.

ON-GOING BENCH FEE (£300/TB PER MONTH)

Includes any data transfers, software updates etc.

VETTING COSTS

All data lab users require vetting clearance. The minimum requirement is BPSS and provides access to the Blue zone. Dependent on the data being accessed a higher clearance may be required by the data provider and the costs and timings for each level of clearance are given below.

Clearance level	Cost	Estimated time
Baseline Personal Security Standard	£145	2-6 weeks
Non-Police Personnel Vetting - Level 3	£220	12 - 26 weeks
Non-Police Personnel Vetting - Level 3 + Security Check	£250	26 - 38 weeks

Note: NPPV clearances are conducted by Warwickshire and West Mercia police and may not be accepted by other police forces. Security Check is a national clearance conducted through UK National Vetting Services, the central body for all government-level clearances.
