February & March 2024 Assessment dates

FS1 12-month interim assessments: Assessments must be completed between 5th - 26th February 2024.

FS1 18-month assessments: Assessments will take place between Monday 19th February- Friday 1st March 2024.

All FS2 written tasks must be submitted electronically via Moodle: Friday 1st March 2024 by 12pm (noon).

FS2 oral assessments will take place between Monday 4th March - Friday 15th March 2024.

Results will be presented to the **Board of Examiners in April 2024**. Results will be released within two weeks of the meeting; all practitioners will be emailed when available.

June 2024 Assessment dates

FS1 12-month interim assessments: Assessments must be completed between 3rd - 24th June 2024

All FS2 written tasks must be submitted electronically via Moodle: Monday 3rd June 2024 by 12pm noon.

All FS1 18-month and FS2 assessments will take place between 3rd – 14th June 2023.

Results will be presented to the **Board of Examiners in July**. Results will be released within two weeks of the meeting; all practitioners will be emailed when available.

September 2024 Assessment dates

FS1 12-month interim assessments: Assessments must be completed between 2nd - 23rd September 2024.

All FS2 written tasks must be submitted electronically via Moodle: Monday 2nd September 2024 by 12pm (noon).

FS2 Oral assessments will take place between 2nd - 13th September 2024.

FS1 18-month assessments: will take place between 16th - 27th September 2024.

Results will be presented to the **Board of Examiners in November**. Results will be released within two weeks of the meeting.

December 2024 Assessment dates

FS1 12-month interim assessments: Assessments must be completed 25th November 2023- 16th December 2024.

All FS2 written tasks must be submitted electronically via Moodle: Monday 2nd December 2024 by 12pm (noon).

FS2 oral assessments will take place during the week commencing 2nd December 2024.

FS1 18-month assessments will take place during the week commencing 9th December 2024.

Results will be presented to the Board of Examiners on Board in January 2025. Results will be released within two weeks of the meeting.
