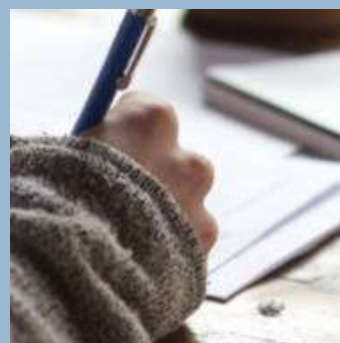

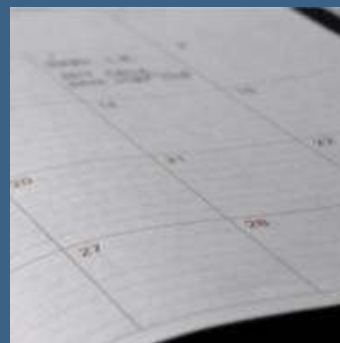

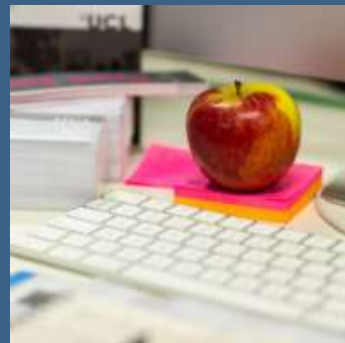
Departmental Managers, ELOs and Board Administrators have now been given increased access to amend Board Admin access on Portico for external examining activities

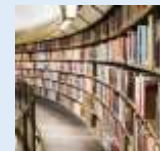
